

**LIST OF
MAIN HAZARDOUS SUBSTANCES AND ITEMS OF PROPERTY
PROHIBITED (OR ALLOWED, PROVIDED THE APPLICABLE REQUIREMENTS ARE
COMPLIED WITH)
FOR TRANSPORTATION ON BOARD THE AIRCRAFT BY CREW MEMBERS
AND PASSENGERS IN THE CHECKED-IN BAGGAGE AND IN ITEMS OF PROPERTY
CARRIED ON BY THE PASSENGERS**

1. It is prohibited to transport the following hazardous substances and items of property on board the aircraft by crew members and passengers in the checked-in baggage and in items of property carried along by passengers:

1.1) explosives, explosive devices and objects filled with them:

- all kinds of gunpowder, in any package and in any quantity
- service cartridges (including small-caliber cartridges)
- cartridges for gas weapons
- hunting caps (pistons)
- pyrotechnics: signal and lighting flares, signal cartridges, landing bombs, smoke cartridges (bombs), demolition matches, sparklers, railway firecrackers
- TNT, dynamite, toluene, ammonal and other explosives
- detonating caps, electric detonators, electric igniters, detonating and fire-conducting cord, etc.

1.2) compressed and liquefied gases:

- household gases (butane-propane) and other gases
- mace-outs filled with nerve and tear gases, etc.

1.3) flammable liquids:

- acetone
- petrol
- samples of flammable petroleum products
- methanol
- methyl acetate (methyl ether)
- carbon disulfide
- ethers
- ethyl cellosol

1.4) flammable solids:

- spontaneously combustible substances
- substances that emit flammable gases when interacting with water
- potassium, sodium, calcium metal and their alloys, phosphorous calcium, etc.;
- white, yellow and red phosphorus and all other substances classified as flammable solids;

1.5) oxidizing substances and organic peroxides:

- colloidal nitrocellulose, in granules or flakes, dry or wet, containing less than 25% water or solvent
- colloidal nitrocellulose, in chunks, wet, containing less than 25% alcohol
- dry or wet nitrocellulose containing less than 30% solvent or 20% water, etc.

1.6) toxic substances;

1.7) radioactive materials;

1.8) caustic and corrosive substances:

- strong inorganic acids: hydrochloric, sulfuric, nitric and others
- hydrofluoric acid and other strong acids and corrosive substances

1.9) *poisonous and toxic substances:*

- any poisonous potent and toxic substances, liquid or solid, packed in any containers
- brucine
- nicotine
- strychnine
- tetrahydrofurfuryl alcohol
- antifreeze
- brake fluid
- ethylene glycol
- mercury
- all salts of hydrocyanic acid and cyanide preparations
- cyclone, black cyanide, arsenous anhydride, etc .
- other hazardous substances, items and cargoes that may be used as a weapon to attack passengers, aircraft crew, and also endanger the flight of the aircraft

1.10) *weapons*

- pistols, revolvers, rifles, carbines and other firearms, gas, pneumatic weapons, electroshock devices, daggers, stiletos, landing-force bayonet knives, unless otherwise specified in and by way of procedure established by the laws of the Russian Federation

A detailed list of hazardous substances and items of property prohibited for transportation on board an aircraft by crew members and passengers is contained in the Technical Instructions for the Safe Transportation of Dangerous Goods by Air (Doc 9284 AN / 905 ICAO)

2. The following items of property and substances may be transported on board the aircraft by crew members and passengers, provided the applicable requirements are complied with:

2.1) *If transported within checked-in baggage, in cargo and baggage compartments of the aircraft, with no access for the passengers to the baggage during the flight:*

- crossbows, spear fishing rifles, cavalry swords, sabers, cleavers, scimitars, broadswords, swords, court swords, bayonets, daggers, hunting knives, ballistic knives, lockable-lock knives or imitators of any type of weapons
- household knives (scissors) with blade length more than 60 mm
- alcoholic beverages containing more than 24%, but not more than 70% alcohol by volume, in containers with a capacity of not more than 5 liters, in containers intended for retail sales – not more than 5 liters per passenger
- liquids and alcoholic beverages containing not more than 24% alcohol by volume
- aerosols intended for use in sports or household purposes, if exhaust valves of their containers are protected by caps against spontaneous release of the contents, in containers with a capacity of not more than 0.5 kg or 500 ml - not more than 2 kg or 2 liters per passenger

2.2) *if transported in items of property carried on by passengers:*

- medical thermometer – one per passenger
- mercury tonometer in a standard case - one per passenger
- mercury barometer or manometer, packed in an airtight container and sealed with the sender's seal
- disposable lighters - one per passenger
- dry ice for cooling perishable food - not more than 2 kg per passenger
- 3% hydrogen peroxide - not more than 100 ml per passenger
- non-hazardous liquids, gels and aerosols:

- if transported in containers with a capacity of not more than 100 ml (or an equivalent capacity in other volume measurement units), packed in a securely closed transparent plastic bag with a volume of not more than 1 liter - one bag per passenger
- Liquids in containers with a capacity of more than 100 ml are not acceptable for transportation, even if the container is only partially filled, with the exception of:
- Medicinal drugs, baby food and products for special dietary needs

Liquids purchased from duty-free shops at the airport or on board the aircraft must be packed in a securely sealed plastic bag that provides identification of access to the contents of the bag during the flight, on which there is reliable confirmation that the purchase was made at the airport duty-free shops or on board the aircraft on the date (s) of travel.

The administrative authority of the airport, airline or operator may decide, at its own discretion, to introduce any additional measures to ensure aviation security on any high-risk flights and therefore prohibit the transportation of any of the following items of property in the cabin of an aircraft:

- corkscrews
- hypodermic needles (unless medical justification is provided for their transportation)
- knitting needles
- scissors with a blade length less than 60 mm
- folding knives (without any fixation device) for travels, penknives with length of blade less than 60 mm.
